





Choose between individual and bulk grant application forms. Benefit from in-built help and validation, and effortlessly upload the required evidence.



Frequently Asked Questions

How to create an online account?

You can sign up for a Levy and/or Grant Online account by completing the online registration form.

How to reset my password?

In the portal, click 'Sign in' and then 'Forgot your password?', and follow the steps to send a verification code to your email address and reset your password.

How to remove an online user from my online account?

Only those who have 'Admin' permissions for their employer in the portal can remove user access. For more information please follow the user guide.

To request access to Levy Online, use the same 'Request access to an employer' process as for grant access, but select 'Levy' as your access option. These requests are sent to CITB's Customer Operations team, who will review and respond to grant your access.

How do I get access to both Levy and Grant together?

Levy and Grant Online access must be requested separately. To access both, log into the portal, request access to one, and then submit a request for the other.

As an admin, how do I approve Levy access requests, or manage Levy users at my employer?

The employer admin area allows you to manage access against the Grant Online functions in the new portal. Levy Online is managed through existing processes by our Customer Operations team. As we continue to develop the portal over time, you will be able to manage more accesses directly in the portal, including for Levy.
